AACI National Counselling Conference

AACI Development

AACI DATABASE:

We are currently developing our database to capture more accurate counselling statistics. The primary development is to broaden the range of referrers and to eliminate the number of unrecorded statistics. We will be capturing the number of Child Protection Cases, hours of work involved by the DLP and report writing. We are developing the system to capture the number of both individual and group supervision hours provided by our member agencies. This can be a cost that is over looked and yet a hugely important one. Michelle has been supporting our member agencies to sign up to using our database and we now have 20 member agencies feeding their data, this will really enhance our National Statistics Report in January 2016.

WEBSITE:

We are developing our website so that we can display our annual report and accounts, newsletter and events taking place throughout the year.



REVENUE & GOVERNANCE:

The AACI Board of Directors attended governance training during the year that was hugely helpful in identifying the key areas of development in terms of policies and procedures and in ensuring they have a healthy working relationship with their staff. Michelle McCafferty has been working with our accountant and solicitor to ensure we are compliant with Revenue and Governance.
